Bidders are requested to submit a signed original and one copy of their proposal. In addition to the attachments and other requirements of this Request for Proposal, the proposal shall contain a cover letter, an executive summary, narrative text, and a price proposal. Price proposals shall be separate and shall include a detailed explanation of pricing procedures as well as a cost summary.

Once proposals are received they will be the property of Collins-Maxwell Community School District and shall be public records subject to disclosure under state and federal law.

The administration will recommend their selection to the Collins-Maxwell School Board and will select the proposal at the next School Board meeting, Wednesday March 19th, 2025 following the turn in deadline of Monday, March 10, 2025.

Fire Alarm Summary and Scope

- I. Summary
 - A. The Fire Alarm System at Collins-Maxwell Elementary is outdated and is having several issues with false alarms and dated equipment. The existing system control panel has been updated within the last 3 years and is capable of integrating a fully addressable system. We are looking to update all the devices and add additional devices that were needed per the Fire Marshal's request to make the system fully addressable. It is currently a zone system. The work would be required to be completed over the summer break between June 2nd and August 14, 2025. This is to avoid as many conflicts with school staff and students.
- II. Scope
 - A. Utilizing the current control panel
 - B. Pull wire for all new devices
 - C. Install new fully addressable devices
 - 1. Some additional devices are needed in the basement area but it should be a 1 for 1 install
 - D. Remove old devices
 - 1. Deactivate and remove old keypad for the old security system so it is not connected to fire alarm
 - E. Complete test and coordinate with the Fire Marshal

- B. Key Pad to be deactivated and removed
 - 1. DSC LCD4501 Programmable Maxsys LCD Keypad
